FEES

1. All food vendor fees for the 2011 River to Reef must be paid with the application by one of the following methods:

3. All site payments must be received by Friday 12 August, 4.30pm at the latest
4. You will be issued with a receipt as proof of payment.

CONDITIONS

The following conditions have been implemented to present a quality event and service for the benefit of the community and our Food Vendors. Should you require any assistance in meeting any of the following criteria, please contact the Festival and Events Team 49619767 or 49619765.

1. Food handling facilities and service must comply with the Mackay Regional Council Health and Regulatory Service Division. A copy of your Temporary Food Permit or License must be supplied to the Festival and Events team prior to the event along with your application.
2. All Food Vendors will be positioned at the Event Coordinators discretion
3. Car permits must be made visible to security personnel upon entering the festival site. Please position your permit on the drivers side of your car's dash board
4. All Food Vendors must hold a current public liability insurance policy with a minimum cover required for their specific products or services
5. All Food Vendors must supply their own marquee (where applicable) and materials.
6. Equipment to secure marquees must be supplied by the vendor (eg. Sand bags, weights etc.)
7. Food Vendors are responsible for the bulk rubbish removal from their allocated site area
8. Food Vendors are liable for restoration claims for any damage they may cause to the site areas.
9. Failure to comply with all conditions may lead to withdrawal of your site.
10. Any incidents which may result in disruption of the peace during the event must be reported to uniformed security staff on the day.
11. Food Vendors may be filmed or photographed during the event and agree for footage and images to be used for promotional use by Mackay Regional Council.
12. Application forms and payment must be completed and returned by Friday 12 August 2011.
